## PROGRAM REMINDERS



### Obligate YOUR Funds: August 30, 2024

- You **MUST** obligate your Local Match Funds by August 30, 2024
- You can obligate by providing one of the following:
  - Executed contracts for goods/services.
  - Executed Memorandum of Understanding (MOU).



### Upload YOUR Procurement Documentation

- You **MUST** upload all procurement documents within 15 days of execution of a contract to the MCWI portal.
- No reimbursements will be paid until procurement documents have been uploaded, reviewed, and approved.



### Having troubling obligating? Use a MOU!

- You can now use a MOU to obligate your Local Match Funds.

## FEATURED PROJECTS

### > City of Vicksburg – Water Plant Improvements

**Project Scope:** The Project will replace valves and fitting, construct a new groundwater well, install a backwash pump, and install new lines between the clarifier and filter at the drinking water treatment plant.

**Project Impact:** This investment in the drinking water system upgrades is estimated to impact roughly 30,000 Mississippians across two counties. These necessary upgrades will also enable the City to be better suited for future economic development by increasing the City's drinking water capacity.

### > City of Philadelphia – Wastewater Treatment Project

**Project Scope:** The Project includes wastewater treatment lagoon levee repair and rehabilitation.

**Project Impact:** This investment in the wastewater lagoon system is estimated to impact roughly 7,000 Mississippians. These necessary upgrades will benefit the City for over 50 years and help the City attract new industries. These necessary upgrades will counteract wind erosion that has damaged the lagoon over time.
